

# Franconia Basecamp Consignment Agreement

Updated: 3/24/2022

- 1. CONSIGNMENTS:** The consignor has provided the goods described to Franconia Basecamp for sale on a consignment basis under the terms and conditions of this agreement. The consignor acknowledges that they have the legal right to consign/sell the property provided. Franconia Basecamp reserves the right to refuse items for consignment for any reason.
- 2. CONSIGNMENT RATES:** Consignment rates are based on the final sale value of each item. Consignors will be credited **50%** of the sale price in form of a check or **60%** in store credit. Consignors may also choose to donate their earnings to the current non-profit/community partner.
- 3. PRICING:** Franconia Basecamp will set an initial sale price based on condition, demand, sales history, and the original retail price. We generally start at 30-50% of full retail and adjust from there. Items will be marked down on a monthly or seasonal basis until sold. On the first of the month the selling price of consigned items are discounted by the following amounts: 0% during the first month or portion thereof, 10% during the second month, 25% during the third month and 50% during the fourth month. Franconia Basecamp reserves the right to reduce prices further for sales or other promotions. In the event of an item not selling within 120 days, the item becomes the property of Franconia Basecamp. It is the responsibility of the consignor to retrieve unsold merchandise before 120 days have expired, as consignors will not be notified as the expiration date nears. At any time within the 120 days, items can be taken off consignment by the seller. Franconia Basecamp reserves the right to remove items from inventory at any point for any reason even if initially selected for consignment.
- 4. MEDIA:** Franconia Basecamp reserves the right to use images of items for promotions.
- 5. CLEANING/REPAIR:** Franconia Basecamp only accepts items that are clean, functional, and contain all parts necessary for operation. Clothing and sleeping bags must be washed or dry cleaned prior to consignment. Franconia Basecamp reserves the right to charge a cleaning or a repair fee for any items put on consignment.
- 6. LIABILITY:** Franconia Basecamp is not responsible for damaged, lost, stolen, or destroyed property. The consignor agrees to indemnify and hold harmless Franconia Basecamp from any and all liability, claims, suits, proceedings, demands, losses, or damages of any nature.
